# Now Available: OACDCarbon.Org Carbon Sequestration and Soil Health Website and Guidebook





Hello Conservation Colleagues,

First, I want to say how great it was to meet so many of you at our Annual Conference! Nothing is as good as face-to-face interactions. We had 84 attendees over the 3 days, it was a great turnout, and I was very impressed by the level of engagement during the Q&A periods of each session. I learned a lot and I hope you all did as well. I am already working on next year, reading feedback and planning early so we can make next year even better!

There were a couple of takeaways from the conference that I want to share more broadly:

- 1 We have made a change to the OACD Board Meetings. We have added a "**District Comments**" section a time for any District that wants to give feedback or raise an issue to the Board. I will be putting the monthly meeting and link in the "Coming Events" section of the newsletter (and yes, it will be added to the website when I sit down to do an overhaul of the website hopefully this winter).
- 2 **District Manager Roundtables** We will be holding topic-centered virtual roundtables quarterly and will set up a google-based resource library. Stay tuned for more information on that.

As you saw on the cover of the newsletter, OACD completed a carbon sequestration and soil health users' website and guidebook to provide information, tools, financial resources and demonstration projects that can be used by Soil and Water Conservation Districts and their landowners, in addition to others who work with natural climate solutions. There are 8 sections that go into detail and provide research materials and articles regarding practices and other material. Section 6 includes the information about the new legislation on natural climate solutions.

Before I turn you over to the rest of the newsletter – here's the reminder to **VOTE!** Ballots for the OACD Board are due to me by **November 30.** Each district can submit <u>one</u> ballot representing the district's choices. #### Webinar on the NEW Private Forest Accord Grants - November 16

The Oregon Department of Fish and Wildlife is announcing a new funding opportunity that will benefit aquatic fish and wildlife throughout Oregon: Private Forest Accord Grant Program. This Grant Program results from a historic agreement between the timber and conservation groups, which has increased protections for stream and aquatic species' habitat while allowing forest management practices to continue on private lands. The PFA Grant Program plans to hold its first annual solicitation in November, closing on December 31st, to award up to \$10 million in funding for projects that benefit the aquatic fish and wildlife species covered by the anticipated Oregon Department of Forestry Habitat Conservation Plan (HCP). #### **Weed Grants**

The Oregon Department of Agriculture is now accepting applications for 2024 Oregon Noxious Weed Grants. There is \$3.25 million this biennium that will be awarded to noxious weed work, \$500,000 of those funds will be for ODA County Noxious Weed Grants.



Applications are due at 5 pm on Friday, December 15, 2023.

Grant Cycle for Approved Grants will be for work February 2024 thru April 30, 2025.

#### Watershed Toxics Reduction Program & Action Plan - CTGR

The Confederated Tribes of Grand Ronde is seeking proposals to develop a watershed toxics reduction program and action plan. The focus area is the Willamette River, which is located within the Columbia River Basin. The selected entity is desired to work under a Tribal contract during 2024 – 2028. ### **USFWS Fish Passage Funding**

The U.S. Fish and Wildlife Service announced the availability of up to \$36 million through President Biden's Investing in America agenda for fish passage projects that address outdated, unsafe or obsolete dams, culverts, levees and other barriers fragmenting our nation's rivers and streams. The National Fish Passage Program, will prioritize projects that will:

- Maximize benefits to priority species and habitats.
- Provide sustainable fish passage.
- Leverage regional or watershed priorities for habitat restoration, fish passage or aquatic connectivity.
- Enhance community resilience to climate change, address public safety hazards and provide other benefits such as job creation or recreational fishing opportunities.
- Support or engage with disadvantaged communities.
- Coordinate on species and watershed priorities with Tribes and states.
- Be supported by partners, affected stakeholders, and the local community.

Interested parties should submit a Letter of Interest to the appropriate National Fish Passage Program regional coordinator, via email, no later than <u>Nov. 17, 2023</u>. #### NRCS Oregon Announces Sign-Up Period for the Agricultural Conservation Easement Program

The U.S. Department of Agriculture (USDA) Natural Resources Conservation Service (NRCS) in Oregon is accepting applications from agricultural producers and forest landowners for the <u>Agricultural Conservation</u> <u>Easement Program</u> (ACEP). The ACEP program helps producers enroll working lands and wetlands into conservation easements.

While NRCS accepts ACEP applications year-round, the deadline to be considered for the fiscal year 2024 funding cycle is **December 15, 2023**.

# **Drinking Water Provider Partnership Requesting Proposals for Restoration of Water Quality and Fish Habitat**

The Drinking Water Providers Partnership (DWPP) is inviting project proposals for 2024 requesting up to \$150,000. The partnership includes USDA Forest Service, Geos Institute, Oregon DEQ, Washington Department of Health, U.S. EPA, U.S. BLM, WildEarth Guardians, and The Freshwater Trust. This watershed restoration funding opportunity is for water providers and watershed restoration practitioners in OR and WA. The goals of the DWPP are to:

- Restore and protect the health of watersheds and water quality which communities depend upon for drinking water
- o Improve aquatic and riparian ecosystems, including the native fish that inhabit them
- Support local partnerships of drinking water providers, landowners and restoration experts that successfully implement restoration projects

# NRCS Expansion of Climate-Smart Agriculture and Forestry Activities supported by the Inflation Reduction Act

NRCS is increasing <u>Climate-Smart Agricultural and Forestry Mitigation Activities</u> eligible for Inflation Reduction Act funding for fiscal year 2024 through the <u>Environmental Quality Incentives Program</u> (EQIP) and Conservation Stewardship Program (CSP). These in-demand activities are expected to deliver reductions in greenhouse gas emissions or increases in carbon sequestration as well as significant other benefits to natural resources like soil health, water quality, pollinator and wildlife habitat and air quality. In response to feedback received from conservation partners, producers and NRCS staff across the country, NRCS considered and evaluated activities based on scientific literature demonstrating expected climate change mitigation benefits. #### **NOAA Funding Opportunities**

There are several federal funding opportunities this fall for fish habitat work through the National Oceanic and Atmospheric Administration (NOAA). While some of these opportunities are referred to as coastal grants, the definition of coastal areas eligible for project funding is quite broad and includes areas located along inland rivers and streams with a significant impact on coastal and ocean resources. Anadromous fish habitat work anywhere in the state may be eligible.
